DRAFT MINUTES

Summary of Board of Directors Stationary Source Committee Meeting Monday, February 1, 2016

1. CALL TO ORDER – ROLL CALL

Stationary Source Committee (Committee) Chairperson John Gioia called the meeting to order at 9:37 a.m.

- Present: Committee Chairperson John Gioia; Vice-Chairperson James Spering; and Directors John Avalos, Scott Haggerty, David Hudson, Eric Mar and Jan Pepper.
- Absent: Directors Carole Groom and Jan Pepper.

Also noted: Director Kniss.

2. PUBLIC COMMENT ON NON-AGENDA MATTERS

Greg Karas, Communities for a Better Environment, addressed the Committee in appreciation of their efforts to work with community groups on emissions caps, and requested that refineries be forced to share more information that is deemed confidential.

NOTED PRESENT: Director Haggarty was noted present at 9:40 a.m.

3. APPROVAL OF THE MINUTES OF SEPTEMBER 21, 2015

Committee Comments: None.

Public Comments: No requests received.

4. REGULATION 2, RULE 5: NEW SOURCE REVIEW OF TOXIC AIR CONTAMINANTS AMENDMENTS

Carol Allen, Supervising Air Quality Engineer, gave the staff presentation, *Regulation 2, Rule 5, New Source Review of Toxic Air Contaminants: Proposed Amendments*, including outline; background; stationary source programs; statewide guidance for Regulation 2, Rule 5; new source review for toxic air contaminants; health risk assessment guideline changes; summary or Regulation 2, Rule 5; proposed changes; impacts of revisions; public outreach; and next steps.

NOTED PRESENT: Directors Avalos and Kniss were noted present at 9:50 a.m.

Committee Comments:

The Committee and Staff discussed the summary on exposure levels including residential exposure and factors such as duration and age sensitivity; how multi-pathway toxic air contaminants work; State Bill (SB) 25; District efforts to reduce impacts with Health Risk Assessments; rule revisions increasing the number of projects triggering Health Risk Assessments and increasing the number of projects required to implement risk reduction measures; that Bay Area impacts are less compared to other air districts due to stronger air quality regulations in place; attendance at the open houses held for public outreach; open house locations; impacts on businesses to comply; cost analysis, the cancer risk, industry impacts, guidance, and locations for businesses and communities most impacted; how to properly measure cancer risks; increasing risk of cancer than previously thought; balancing the science of cancer risk with that costs borne by businesses; and achieving diesel reductions and black carbon reductions.

Public Comments:

Kevin Buchan, Western States Petroleum Association, addressed the Committee and Staff with questions around the throughput limits and the requirements for different types of gas stations and different types of receptors.

Committee Comments (continued):

The Committee and Staff continued discussion, asking about when the rule changes were expected, to which staff responded sometime during the upcoming summer.

Committee Action: None.

5. ASSEMBLY BILL (AB) 2588 AIR TOXICS "HOT SPOTS" PROGRAM UPDATE

Eric Stevenson, Director of Meteorology, Measurements, and Rules, gave the staff presentation *Assembly Bill (AB) 2588 Air Toxics "Hot Spots" Update*, including an overview of the program; Air Toxics "Hot Spots" Act; Stationary Source Air Toxics Programs; AB 2588 process; Health Risk Assessments; risk drivers and sources; risks declining; protecting public health and revising risk management threshold; top risk facilities; and schedule.

Committee Comments:

Committee and Staff discussed the use of new protocols which are stricter; a new app. service that delivers gas to your vehicle; lower impacts observed further from the sources; the notification process in state regulations; the use of backup generators; working with affected industries; mobile emissions of diesel engines and amount reduced; the difference between mobile and stationary sources of emissions and the regulations that apply; and localized impacts of diesel emissions.

Public Comments:

Bill Quinn, California Council for Environmental and Economic Balance, addressed the Committee and Staff stating that AB 2588 has successfully helped reduce toxins; that inventories need to be done correctly; and to consider implementing more reduction programs, such as voluntary early risk program, to prevent a Health Risk Assessment from being triggered and/or required.

Committee Comments (continued):

Committee and Staff discussed notifying the public about the science behind the rule development; how the new calculation of risk comes from a better understanding of the effects of Toxic Air Contaminants; considering early risk reduction programs; and the timeline of when changes for AB 2588 will be brought to the Board.

BACKGROUND

On December 16, 2015 the Board of Directors unanimously adopted amendments to Regulation 8, Rule 18: Equipment Leaks ("Rule 8-18"). During the public comment period, refinery stakeholders expressed concern about safety and security issues with implementation of the Rule 8-18 amendments. They expressed concern that refinery personnel could be in danger when identifying and repairing equipment leaks in compliance with Rule 8-18. In addition, they expressed concern about the security of refinery piping and instrumentation diagrams (P&IDs). Board members requested that staff address these concerns.

DISCUSSION

Staff will provide a presentation to the Committee regarding the processes in place to identify equipment that might present a hazard and how Rule 8-18 compliance can be handled safely. The presentation will also address options to maintain security of P&IDs.

Re: Update of Regulation 12, Rule 16 Alternatives

RECOMMENDED ACTION

None; receive and file.

BACKGROUND

On October 15, 2014, the Board of Directors approved Resolution Number 2014-07 directing staff to develop strategies to reduce emissions from petroleum refineries. Specifically, the resolution directed staff to continue development of Regulation 12, Rule 15: Petroleum Refining Emissions Tracking ("Rule 12-15") to track and monitor refinery emissions; to develop Regulation 12, Rule 16 ("Rule 12-16") to set emissions thresholds and mitigate potential emissions increases; and to develop additional rules to reduce emissions from refineries by 20% by 2020, or as much as feasible.

Staff worked with interested stakeholders and released proposed regulatory language and staff reports for four refinery emission reduction rules, Rule 12-15 and Rule 12-16 in October of 2015. The Board of Directors adopted three refinery emission reduction rules/rule amendments (Regulation 6, Rule 5: Fluid Catalytic Cracking Units; Regulation 8, Rule 18: Equipment Leaks; and Regulation 11, Rule 10: Cooling Towers) on December 16, 2015 that will reduce refinery emission reduction measure, Regulation 9, Rule 15 along with an additional refinery emission reduction on April 20, 2016. Staff received a significant number of comments on proposed Rule 12-16, and determined that a different approach was necessary in order to address the concerns of stakeholders, including affected industry and interested community groups. In addition to these efforts, Staff continues to work on other rules that will affect refineries dealing with permitting requirements and with reducing health risks from toxic air contaminants.

As a result of these rule development processes, criteria pollutants are being significantly reduced and health risks from toxic air contaminants will be capped at a more health protective level. These actions will build upon well-established Air District regulations and programs that improve public health. However, further action is needed to address refinery GHG emissions.

The Air District is concerned about the potential impacts of climate change and is developing a Regional Climate Protection Strategy, programs, and regulations to reduce climate pollutants

from a wide range of sources. In the Bay Area, refineries are the largest industrial contributors to climate pollution. While refineries are expected to reduce GHG emissions as part of California's Cap-and-Trade Program that was developed in response to AB 32, Global Warming Solutions Act of 2006, the Cap-and-Trade Program does not require individual facilities to reduce their emissions.

DISCUSSION

Criteria pollutants and toxic air contaminants are being addressed through current rule making activities resulting in significant reductions in criteria pollutant emissions and health risks. As a result, Rule 12-16 will focus on strategies to effectively reduce refinery GHG emissions. Staff have been meeting with stakeholders from community groups and industry to discuss and evaluate options that would reduce GHG at refineries locally while also achieving overall GHG reductions. Air District Staff are evaluating potential options while incorporating feedback and input from stakeholders to limit refinery GHG emissions. These options include but are not limited to the following:

- Direct regulation of greenhouse gases (including methane) from refinery sources;
- Development of requirements for improvement of energy efficiency likely resulting in GHG reductions (similar to a Washington State GHG refinery rule); or,
- Establish a cap on refinery-wide GHG emissions for each facility.

Staff will provide the Committee with information on potential options for reducing climate pollutant emissions from Bay Area refineries and criteria that would be used to compare them.
