

The above-entitled matter, being an Appeal from the issuance of a Further Revised Major Facility Review Permit for Facility No. A0010 (Richmond Refinery), having been filed on November 15, 2006; Notice of Hearing for a Status Hearing held December 14, 2006 where both parties requested proceedings under Docket No. 3488 be consolidated with those under the appeal in Docket No. 3524 was granted; Hearing Board requests both parties to submit a further written status report by June 30, 2008, Hearing Board receives further status report on June 25, 2008 and June 26, 2008 and denies the Appellant's request for further continuance of the matter; Hearing Board schedules a hearing on September 18, 2008 to discuss status and set a schedule for briefly and oral argument which is changed to October 2, 2008 at which time a briefing/oral argument schedule was set. Appellant submits Opening Brief, filed November 7, 2008 and Reply Brief, filed January 9, 2009; Appellant submits Partial Withdrawal, Request to Cancel January 22, 2009

1 Hearing and Request for Further Continuance to which the Hearing Board approves and requests  
2 further status report be submitted by March 20, 2009; Appellant submits Status Report, filed  
3 March 19, 2009 and requests further continuance so that a further status report may be submitted  
4 by parties within 60 days following issuance of the renewed Title V Permit, or on March 31, 2010,  
5 whichever occurs first to which Hearing Board approves; Appellant submits Status Report on  
6 August 4, 2010 after being notified by Hearing Board of non-receipt and requests further  
7 continuance to August 31, 2011 to which the Hearing Board grants to March 31, 2011; Appellant  
8 files Status Report on March 29, 2011 and requests further continuance and provides a summary  
9 chronology to which the Hearing Board grants further continuance to August 1, 2011; Appellant  
10 submits Status Report on August 1, 2011 and requests further continuance to which the Hearing  
11 Board grants and requests further Status Report be submitted by September 15, 2011; Appellant  
12 having withdrawn its Appeal on September 8, 2011

13 FOR GOOD CAUSE, in accordance with Section 5.7 of the Hearing Board Rules, the  
14 HEARING BOARD ORDERS that the Appeal be and is hereby dismissed.
