## **Air District seeks public input on draft Regional Plug-In Electric Vehicle Readiness Plan**

*Plan will offer strategies for Bay Area transition to zero-emission vehicles*

**SAN FRANCISCO** – The Bay Area Air Quality Management District today announced the release of a regional Plug-In Electric Vehicle, or PEV, Readiness Plan for the Bay Area and Monterey Bay regions.

The PEV Readiness Plan is both a regional and statewide effort co-sponsored by the United States Department of Energy and California Energy Commission that seeks to identify the systems and resources that are needed to support accelerated plug-in electric vehicle deployment, infrastructure, investment and readiness in the region.

The draft plan and two initial planning documents, the Planning Concepts document and the Local Best Practices document, are currently available for review and comment.
