**SUBJECT: ASBESTOS OPERATIONS FEE INCREASE**

On June 18, 2014, the Air District Board of Directors approved a new fee schedule for asbestos operations (demolitions and renovations). The new fees apply to notifications postmarked on or after July 1, 2014. Full payment of fees is required at the time of notification submittal. The fee schedule for Asbestos Operations is on the reverse side. *Additionally, for building departments, a copy of the demolition notification form is attached for use. Please recycle any old forms.*
