## Municipal Solid Waste Landfills

*This Advisory is provided to inform you about activities of the Air District which may affect your operation. It is intended to assist you in your effort to achieve and maintain compliance with applicable air pollution regulations.*

### SUBJECT: Enforcement Advisory - Municipal Solid Waste Landfill Annual Report

---

The **Annual Report** for Municipal Solid Waste (MSW) Landfill is due by **March 15, 2013** includes data collected from January 1, 2012 to December 31, 2012 as detailed in CARB CCR Title 17 section 95470(b)(3)(A)-(J). <http://www.arb.ca.gov/regact/2009/landfills09/landfillfinalfro.pdf>

This includes the following:

- MSW landfill name, owner and operator, address, and solid waste information system (SWIS) identification number
- Total Volume of Landfill gas collected (std. cu. ft.)
- Average composition of the landfill gas collected for this period
- Gas control device type, year installed, rating, fuel type & total amount landfill gas combusted in each control device
- Date the gas collection & control system was installed **and** fully operational
- Percent methane destruction efficiency of each gas control device
- Type & amount of supplemental fuels burned with landfill gas in each device
- Total volume of landfill gas shipped off-site, composition of the landfill gas collected (expressed in % methane & % CO<sub>2</sub> by volume) & recipient of the landfill gas
- Most recent topographic map of site with final cover & % geomembrane coverage
- Summary of records kept by the owner/operator as specified in section 95470(a)(1)(A)-(F), 94570(a)(1)(H) and 95470(a)(1)(K)

*Additionally*

- The reports are to be certified to be truthful, accurate, complete and signed by a responsible official

If you feel you this annual report requirement does not apply to your landfill, you must submit a letter specifically citing the section that exempts your landfill from this requirement to the District by March 15, 2013.

If the District does not receive either an Annual report or a letter citing specific exemption for your landfill the District will take enforcement action.
