Based on our information from the senior engineer Steve Moore for Palomar, all has been working properly over these past two years.

Also attached below is a zip file for the minute by minute CEMS data for two days (or portions thereof) in May 2007 and October 2007 for startups (one regular, one cold combustion turbine and hot steam turbine and one cold combustion and cold steam turbine). The District also has all of 2006 minute by minute CEMS for both turbines for all of 2006, although based on my understanding, the system discussed in our Feb. 6, 2009 letter was installed in Oct. 06. If you would like that information for all of 2006 or believe it may be relevant, let me know, as the Air District did gather that information together, but I wanted to confirm first with you whether you would want it, perhaps from Oct. 6, 2006 until the end of the year. Let me know.

Also, my March 31, 2009 letter to you should be posted and included as part of the administrative record as well as this communication. As I mentioned before, if there are any other issues which have been raised by Calpine or RCEC attacking Chabot-Las Positas's position, please let me know so that we can promptly address them.
