Dear Mr. Neubacher:

The District received an application on June 26, 2008 for a new power plant (Marsh Landing Generating Station) that is subject to PSD permitting requirements. The application was deemed complete on June 30, 2008. The proposed power plant is located adjacent to the existing Mirant Delta facility. Please note the Gateway Generating Station is also adjacent to the Mirant Delta facility.

The Marsh Landing Generating Station would be located at Wilbur Avenue in Antioch, Contra Costa County. The project previously was a 930 megawatt (MW) power plant consisting of two Siemens FP10 combined cycle units and two Siemens 5000F simple cycle units. The project has been amended and as proposed will be a 760 MW power plant consisting of four Siemens 5000F simple cycle units operating a maximum of 1752 hours per year. The District received an amendment to the permit application on September 22, 2009.

The District is providing notice that the project has changed as described above and is providing electronic copies of the relevant information contained in the permit application. Please note the attached CD has the original permit documents and the amended permit documents.

The purpose of this letter is to notify the Federal Land Manager per the PSD delegation agreement (VL3(a)) that the application for the project has been received and deemed complete on September 22, 2009. This notice also provides the information required by 40 CFR Part 52.21 (p).
