The Bay Area Air Quality Management District (the "District") is a local agency that regulates stationary sources of air pollution such as factories, industrial sites, and gasoline stations.

Whenever we receive a permit application for a new or modified source(s) of toxic air contaminants located within 1,000 feet of a school site, State law requires that we notify the public. To comply with this requirement, we distribute or mail a Public Notice to the parents or guardians of students enrolled at schools located within ¼ mile, and all residents and businesses located within 1,000 feet, of the proposed source.

You are receiving this Public Notice because a permit application has been filed with the District for the above referenced source of air pollution. A description of the proposed project follows:

Bodean Company has applied for Authorities to Construct and/or Permits to Operate three new hot mix asphalt silos at its Santa Rosa facility. This project will install three silos along with a conveyor system. The hot mix asphalt is loaded into the silos from the top of the silos, and is loaded into trucks underneath the silos. A new drag conveyor will be installed to transport materials from the existing drag conveyor to the new silos, and two new horizontal conveyors will be added to transport materials from the new drag conveyor to two of the new silos. In addition, the facility proposed to install a Blue Smoke Control System to abate emissions from silo loading and truck load-out at the three new silos.
