**NOTICE INVITING WRITTEN PUBLIC COMMENTS**

**NOTICE** is hereby given that the Bay Area Air Quality Management District is reopening the Major Facility Review Permit for the following Facility:

The facility above received its initial Title V permit on December 1, 2003. On October 8, 2004, EPA found that cause existed to reopen the permit to address specific deficiencies. On December 15, 2004 the facility was given notice that the permit would be reopened to add monitoring to demonstrate compliance with thermal oxidizer destruction efficiency requirements. The proposed permit changes have no effect on emissions. All changes are clearly shown in "strikeout/underline format" and have been addressed in the permit evaluation/statement of basis. All comments must be received by March 15, 2005. The public may also request a public hearing for this reopening of the permit. .

Reopenings of Major Facility Review Permits are also subject to review and approval by US EPA. If US EPA has not objected to a proposed permit and the District has not addressed a public comment in a satisfactory manner, the public may petition US EPA, Region IX, Operating Permits Section at 75 Hawthorne Street, San Francisco, CA 94105, within 60 days after the end of US EPA's review, to reconsider the decision to not object to the permit.
