This reopening of the Title V permit addresses permit deficiencies identified by the EPA on October 8, 2004. The reopening also incorporates changes in applicable requirements authorized in Authorities to Construct, and addresses issues raised in the refinery's appeals and comments. The Authorities to Construct are the following: 3930, 4106, 4192, 4688, 4695, 6745, 9504, 10053, 11157, 12473, 12732, 13078, 13086, 13410, and 14224. The following Title V applications are associated with the above Authorities to Construct and are also being finalized in this action: 9699, 11158, 12731, and 13085.

The District sent a formal notice of reopening pursuant to BAAQMD Regulation 2-6-415 on December 16, 2004. The regulation requires at least 30 days' notice for any reopening.

The public notice was published on April 21, 2005. The public notice period for Application 12430 ended on May 24, 2005. Comments were received from the facility.

The reopening was proposed to EPA on December 11, 2006. The EPA review period ended on January 25, 2007. EPA did not comment on the proposal.

The District is responding to the facility's Comment #1. A response has not been prepared to Comments #2-#17 because they were not included in this action when the public notice for this reopening was published. Responses will be handled in subsequent revisions. A copy of the comments and the response is attached.

The District has decided to issue the revised permit. The final permit can be viewed and/or downloaded on the BAAQMD website at [http://www.baaqmd.gov/pmt/title\\_v/public\\_notices.htm](http://www.baaqmd.gov/pmt/title_v/public_notices.htm). We will also send the final permit via the Electronic Permit Submittal System.
