Dear Mr. Gouveia:

This is to advise you that the Bay Area Air Quality Management District is proposing a minor revision to the Major Facility Review Permit for Mirant Delta (Facility Number A0012) and is submitting the permit to EPA for review.

The following revisions have been made to the permit:

- Addition of Selective Catalytic Reduction (SCR) to S-5 and S-6, Boilers
- Deletion of out-dated SIP requirements
- Revision of dates of rule adoptions
- Addition of accidental release requirements,
- Correction of citations of BAAQMD Regulation 6 in Section VII.
- Change in name of facility from Southern Energy to Mirant.
- The Gasoline Dispensing Facility and Wipe Cleaning requirements have been updated.

In addition, the permit has been revised to reflect the changes to the Manual of Procedures, Volume 2, Part 3, Major Facility Review, and recent changes to the standard parts of the permit. All changes are clearly shown in strikeout/underline format.

The District will issue the permit after the EPA 45-day review period is over and after addressing any EPA comments.
