The District proposed a Notice Inviting Written Public Comments of the MFR permit for this facility on February 1, 2005.

No comments were received from EPA or the public. Comments were received from the facility. In response to the comments, we made the following additional minor changes:

- The word "or O2" is added after "CO2" to the Standard Conditions, Item L, Number 2 in Section I, because Part 75 allows for the measurement of either CO2 or O2 as diluent in order to correct the NOx measurement to a 3% O2 condition.
- The model identification number of source S-53, Diesel Fire Pump, is changed to 855-F3 in Section II, Equipment List, Table II-A, Permitted Sources.
- The facility contact is changed to Tom Bertolini, Sr. Environmental Engineer.

These are administrative amendments as defined by BAAQMD Regulation 2-6-201.
