Differences between Proposed and Final Permit

1. S301, Sulfur Pit, and A8, Stretford Evaporative Cooler, were not deleted from Condition 22964, part 7, because these sources are not being shut down.
2. The company name "ConocoPhillips" was changed to "Phillips 66" in Condition 23724.
3. The District contact on the first page has been changed from Sanjeev Kamboj to Brian Lusher.
4. The Statement of Basis mistakenly showed Table IV-BB.9B in Section C.VII for S448 instead of Table VII-BB.9B. The correct table was included in the permit.
