Subject: Minor Revision to Major Facility Review Permit for Facility # A0017

Dear Ms. Jordan:

This is to advise you that the Bay Area Air Quality Management District is submitting a proposed minor revision to the Major Facility Review Permit for the Hanson Permanente Cement, Application # 9687, for your review.

The purpose of this revision is to:

- Update capacities in Table IIA based on updated documentation from plant
- Add reactivated Roll Press Clinker Surge Bin and Feeder S-21 to Title V permit
- Add existing Quarry Blasting and Mobile Operations S-600 to Title V permit.
- Add new Finish Mill Building Conveyor S-415 to Title V permit.
- Remove Schedule of Compliance with the installation of updated Bag Leak Detection Systems
- Update tables for S-1 Gasoline Station for EPA approved BAAQMD Regulation 8-7 instead of the SIP Regulation 8-7.
- Update version dates for newly modified regulations.
- Update tables and permit conditions to reflect the additions of permitted equipment.

All changes are clearly shown in strikeout/underline format.

This revision is minor pursuant to BAAQMD Regulation 2-6-215 and will be effective immediately. The permit will be formally re-issued after EPA review. This revision is not subject to public comment and therefore, requires no public notice.
