Dear Ms. Jordan:

This is to advise you that the Bay Area Air Quality Management District is proposing a minor revision to the Major Facility Review Permit for Hanson Permanente Cement and is submitting the permit to EPA for review.

The purpose of this minor permit revision is to modify the permit to reflect changes that were approved under District new source review applications 15217 and 15398. These applications involved the addition of S-444 Emergency Clinker Conveyor and an increase in allowable coke throughput for S-173 Kiln Coke System and S-174 Precalciner Coke System.

This revision is minor pursuant to BAAQMD Regulation 2-6-215 and will be effective immediately. The permit will be formally re-issued after EPA review. This revision is not subject to public comment and therefore, requires no public notice.
