This is to advise you that the Bay Area Air Quality Management District is issuing an administrative amendment to the Major Facility Review permit for the following facility.

The purpose of this amendment is to change the followings:

1. The name of the responsible official, the facility contact and his phone number.
2. The effective date of the National Emission Standards for Hazardous Air Pollutants (NESHAP) for the Portland Cement Manufacturing Industry – Subpart LLL requirements because EPA extended its compliance deadline from September 9, 2013 to September 9, 2015 on December 20, 2012 rule amendment.

All other rule changes will be made prior to September 9, 2015. There have been no changes in the applicable requirements for these sources.

Administrative amendments do not require EPA review and are effective upon issuance.
