Ms. Eden,

Thank you for your email and your interest in the Cement Kiln Rule development process and the Title V permit.

Title V permits are compilations of applicable air quality standards and their associated compliance provisions. In the case of the draft Lehigh permit currently in comment period, the permit includes the new EPA regulations.

However, the upcoming District rule is not yet applicable, and therefore has no bearing in the current permit review. After the rule is adopted, the District will reopen the Title V permit to incorporate the new requirements related to this rule. The appropriate time for public involvement on whether the upcoming rule requirements are adequate or appropriate is during the rule development process (i.e., the workshop, the subsequent period for public comments, and the public hearing for consideration of adoption of the rule).

As we have indicated, we expect to have the rule workshop in the second quarter of 2011. This will be well after the end of the public comment period for the Title V permit renewal, which ends on March 25. That should give persons interested in participating in both the permit and rule development process plenty of time to do so without one getting in the way of the other.

At this point, there are no plans to modify the deadline for comments on the Title V permit.

Hi Jim: I see that a workshop, 2nd quarter, 2011, and a public hearing, 3rd quarter, 2011, are listed below for Cement kilns (SSM-9), New Rule (as well as noted for the March 3, 2011, Stationary Source Cttee, although the workshop does not appear on the agenda). As per our discussion, you have informed me that the workshop is not on the stationary source cttee agenda of March 3, 2011,, and the workshop and public hearing for the new cement kiln rule have not been scheduled.

I would like you and those copied on this list to know that the baaqmd has set the due date for the draft Title V Air Permit public comments on the Lehigh Sourthwest cement plant and kiln and operation per Title V of March 25, 2011.

Since there is to be a workshop in the 2nd quarter and a public hearing in the 3rd quarter (although not yet specifically scheduled) on the cement kiln rule, and since Brian Bateman of the baaqmd has told us that the Lehigh Cement Kiln Title V draft permit will contain the new cement plant/kiln EPA rules, we should certainly have the opportunity to attend a workshop on this rule before the Title V comments are due. That obviously would also go for the right to public hearing on the new cement kiln rules.

In addition, it would be completely inappropriate to now schedule a workshop or a public hearing before the Title V comments are due, as that is a large, technical document and the public would not have the time to both go to the workshop and the public hearing on the cement kiln rule, which is an important component of the draft Title V Permit, before the Title V public comment due date of March 25.

Therefore, I ask that the Title V permit deadline be extended in order for both the cement kiln rule workshop and the cement kiln rule public hearing be scheduled with adequate advance notice to the public well before the draft Title V Lehigh Southwest Air Permit public comments are due to the baaqmd.
Please inform me of your actions regarding this request as soon as they are decided.
