This is to advise you that the Bay Area Air Quality Management District is issuing the renewal Major Facility Review Permit for the following facility.

The 30-day public comment period for the proposed renewal permit ended on September 15, 2011 and the 45-day EPA review period ended on September 28, 2011. The District did not receive any comments on the proposed permit from the public, EPA, or ARB.

The draft permit did not include 40 CFR Part 63, Subpart ZZZZ, National Emission Standards for Hazardous Air Pollutants (NESHAPs) for Reciprocating Internal Combustion Engines. The final permit has been corrected to include Subpart ZZZZ as an applicable requirement. The NESHAP applies to S-47 diesel fire pump engine. The NESHAP has been added to Table IV-J as an applicable requirement along with the applicable portions of 40 CFR Part 63 Subpart A, General Provisions.

The District has decided to issue the renewal permit.
