The District has made a preliminary decision to issue the renewal Major Facility Review Permit, but the final decision on the permit issuance will consider public and EPA comments on the proposed permit. The notice inviting written public comments will be published in the Contra Costa Times. The final date for members of the public to submit comments is September 15, 2011.
