

NOTICE INVITING WRITTEN PUBLIC COMMENTS

NOTICE is hereby given that the Executive Officer/Air Pollution Control Officer of the Bay Area Air Quality Management District (BAAQMD) invites interested persons to submit written public comments on the proposed significant revision of the Major Facility Review Permit for the Facilities A0016 and A0022, and the initial permit for Facility B7419:

These permits are being proposed together because they are one project.

Major facilities are required to obtain operating permits under Title V of the 1990 Clean Air Act Amendments, the Federal Operating Permit Program and BAAQMD Regulation 2, Rule 6 - Major Facility Review. The permits summarize all air pollution regulation requirements that apply to each source of emissions at each facility.

The purpose of this action is to issue permits for the Clean Fuels Expansion Project, which consists of additional hydrocracking and sulfur recovery capacity at the refinery, a new hydrogen plant, and emission reductions at the carbon plant. This action also resolves items appealed in the permit that was issued on December 1, 2003, and incorporates some minor revisions. The change in emissions resulting from the action is:

The emissions are shown for the pollutants that the facilities will emit in quantities over one ton per year. The detail for other air pollutants is included in Applications 13424 and 13678.

The Air Pollution Control Officer invites written comment on the proposed permits described above. Comments must be received by May 25, 2009. Any interested person may also request a public hearing for this project.

Major Facility Review Permits are also subject to review and approval by US EPA. If US EPA has not objected to a proposed permit and the District has not addressed a public comment in a satisfactory manner, the public may petition US EPA, Region IX, Operating Permits Section at 75 Hawthorne Street, San Francisco, CA 94105, within 60 days after the end of US EPA's review, to reconsider the decision to not object to the permit.
