This is to advise you that the Bay Area Air Quality Management District is issuing an administrative amendment to the Major Facility Review permit for the following facility.

The purpose of this amendment is to add non-federally enforceable permit condition 19758, parts 1 through 6 to the permit for S-32 and S-33 diesel engines to ensure compliance with the stationary diesel engine air toxics control measure. The compliance schedule under Section V of the permit has been removed since S-32 and S-33 are now in compliance with the air toxics control measure. Obsolete condition 19758, part 1 that required recordkeeping of the fuel sulfur content certified by the fuel vendor has been removed because the facility can only purchase ARB ultra-low sulfur diesel fuel that meets a 15 ppm total sulfur content specification. References to Regulation 9, Rule 8, the ATCM, and revised condition 19758 were updated as necessary throughout the permit.

Administrative amendments do not require EPA review and are effective upon issuance.
