This is to advise you that the Bay Area Air Quality Management District is issuing the renewal Major Facility Review Permit for the following facility.

The 30-day public comment period for the proposed renewal permit ended on August 2, 2011 and the 45-day EPA review period ended on August 15, 2011. The District did not receive any comments on the proposed permit from the public or the facility. The District received several comments from EPA on the proposed permit and statement of basis. In response to those comments, the District made the following changes to the permit:

- Added the applicable provisions of 40 CFR 63, Subpart ZZZZ to the Part IV and VII tables for S-34 Caustic Pump Diesel Engine and S-35 Natural Gas Fired IC Engine
- Added pre-control device potential to emit calculations for several sources to the statement of basis to show that CAM does not apply to those sources

The District has decided to issue the renewal permit.
