- Owens-Brockway's permit has been amended to incorporate the following changes:
- 1) The daily capacities of S11 and S12, Glass Furnaces, have been corrected to 357 and 314 tons per day.
 - 2) The capacity of S39, Raw Material Unloading Station, has been corrected to 60 tons per hour.
 - 3) A new condition has been added to Section I of the Permit. Condition I.J reads: "The maximum capacity for each source as shown in Table II-A is the maximum allowable capacity. Exceedance of the maximum allowable capacity for any source is a violation of Regulation 2, Rule 1, Section 301. (Regulation 2-1-301)". A note has also been added to Table II.A, Equipment List, that refers to this standard condition. Regulation 2-1-301 requires an application for any increase in capacity.
 - 4) The deadline for installation of the continuous emission monitor for NOx at S10, Glass Furnace, has been extended to December 1, 2000.
 - 5) The recordkeeping for glass production at the furnaces has been changed from a monthly to a daily basis, and a recordkeeping procedure has been added.

The District has received no comments from EPA or the public on the draft permit sent to you, and has made a decision to issue the Major Facility Review Permit.
