This is to advise you that the Bay Area Air Quality Management District is issuing a minor revision to the Major Facility Review Permit for the following facility.

The purpose of this action is to revise the carbon monoxide emission limit for S-36 and S-37 Engine Generators to reflect a change approved under BAAQMD application 17754. The proposed permit also includes the addition of the amended Regulation 9, Rule 8 that applies to internal combustion engines.

The 45-day EPA review period ended on August 10, 2008. No comments on the proposed minor revision were received from EPA, ARB, or the facility.

The District has decided to issue the permit incorporating the proposed minor revision.
