

## NOTICE INVITING WRITTEN PUBLIC COMMENTS

**NOTICE** is hereby given that the Air Pollution Control Officer of the Bay Area Air Quality Management District invites interested persons to submit written public comments on the proposed significant revision to the Major Facility Review Permit for the following Facility:

The purpose of this revision is to increase the maximum firing capacity and the landfill gas throughput limits at the flare. This revision will also make several minor corrections to permit conditions for the flare and to other sections of the permit.

The proposed changes will increase the maximum permitted flare emissions as shown in the table below.

The Executive Officer/Air Pollution Control Officer invites written comment on the proposed significant revision. Comments must be received September 27, 2004. The public may also request a public hearing for this significant revision.

Significant revisions of Major Facility Review Permits are also subject to review and approval by US EPA. If US EPA has not objected to a proposed significant revision and District has not addressed a public comment in a satisfactory manner, the public may petition US EPA, Region IX, Operating Permits Section at 75 Hawthorne Street, San Francisco, CA 94105, within 60 days after the end of US EPA's review, to reconsider the issuance of the permit.
