

NOTICE INVITING WRITTEN PUBLIC COMMENT

NOTICE is hereby given that the Bay Area Air Quality Management District invites written comments on the proposed renewal of a Major Facility Review Permit for the following Facility:

Notice is also given that permit conditions have been changed to improve monitoring, clarity, and enforceability, to remove obsolete conditions, and to add throughput limits pursuant to BAAQMD Regulation 2, Rule 2, as amended on May 17, 2000.

The emissions change since the permit was originally permitted in 1997 is estimated below. The estimated emissions have decreased by:

| Pollutant | Quantity |
|-----------------------------|--------------|
| Nitrogen Oxides | 65 tons/year |
| Precursor Organic Compounds | 6 tons/year |
| Sulfur Dioxide | 3 tons/year |

The District invites written comment on the above proposed permit. Comments must be received by June 18, 2004. The public may also request a public hearing for this permit.

Renewals of Title V Permits are also subject to review and approval by US EPA. If US EPA has not objected to a proposed permit and District has not addressed a public comment in a satisfactory manner, the public may petition US EPA, Region IX, Operating Permits Section at 75 Hawthorne Street, San Francisco, CA 94105, within 60 days after the end of US EPA's review, to reconsider the decision to not object to the permit.
