The requirements for public and EPA review of the following proposed Major Facility Review Permit have been completed:

No comments were received from the public or EPA.

In response to facility comments, several administrative corrections were made regarding a recently completed project, approved in permit application 3319, to replace the old belt filter press operation (S-162) with improved reliability centrifuges S-180. Changes include the following:

- Archiving of source S-162 Sludge Handling (5 Belt Filter Presses); replaced by source S-180 Sludge Handling (4 Centrifuges). There was no change in capacities and no emissions increase associated with this recently completed [phased-in] project. This action as well some required very minor administrative changes associated with Application 3319 are addressed in the Statement of Basis and in the MFR Permit and are explained further in the attached District letter (dated 7-8-2004) of response to the facility comments letter (dated 6-9-2004).

In response to staff comments, the following additional correction was made:

- Addition of the following language to Standard Condition I.B.1 to incorporate the application shield in accordance with BAAQMD Regulation 2-6-407:  
" If the permit renewal has not been issued by \_\_\_\_\_, but a complete application for renewal has been submitted in accordance with the above deadlines, the existing permit will continue in force until the District takes final action on the renewal application. (Regulation 2-6-407)"

The District has decided to issue the revised permit.
