This is to advise you that the Bay Area Air Quality Management District is proposing a minor revision to the Major Facility Review permit for the following facility and is submitting the permit to EPA for review:

The purpose of this minor permit revision is to change the Permit Condition No. 25080 for S-16 and S-17, natural gas fired hot water heaters.

Table IV-D and Table VII-D for S-14, S-15, S-16, and S-17 were changed to reflect the revisions made on Permit Condition No. 25080. Permit Condition No. 25080 in Part VI was changed to reflect the revisions made and approved under Application No. 23441.

This revision is minor pursuant to BAAQMD Regulation 2-6-215 and will be effective immediately. The permit will be formally issued after EPA review. This revision is not subject to public comment and therefore, requires no public notice.
