On August 25, 2005, the District proposed a minor permit revision for this facility. This revision concerned the addition of the S-46 Hazardous Waste Management Facility (HWMF), the proposed gas collection system (19 horizontal collectors) for S-46, and the proposed control system (A-11 Landfill Gas Flare for HWMF) for S-46. This minor revision resulted in a total of 1.72 tons/year of POC from S-46 and secondary emissions of 6.86 tons/year of CO, 1.37 tons/year of NO_x, 1.14 tons/year of SO₂, 0.39 tons/year of PM₁₀ from A-11. The new flare is subject to RACT for CO, NO_x, SO₂, and PM₁₀ emissions. NO_x and POC emission increases were offset by excess contemporaneous on-site emission reductions.
