The District is proposing a Significant Revision of the Major Facility Review Permit.

Application Number	Facility Number	Facility Name	Address	Type of Operation
11374	A1840	West Contra Costa Sanitary Landfill, Inc.	Foot of Parr Boulevard Richmond, CA 94801	Solid Waste Landfill & Electrical Generation

The primary purpose of this revision is to change the permitted capacity of the existing sources, which will allow the facility to accept waste until the fall of 2006; add a new solid waste transfer station source, where waste will continue to be accepted after the fall of 2006 and transported off-site to other disposal sites; and to add the federal requirements to which the facility now becomes subject.

The District has made a preliminary decision to the Significant Revision to the Major Facility Review permit, but the final decision on the permit issuance will consider public and EPA comments on this preliminary decision. The notice inviting written public comments will be published in The Contra Costa Times. The final date for comments is August 15, 2006.
