Subject: Minor Revision to Major Facility Review Permit for Facility # A2039

Dear Ms. Jordan:

This is to advise you that the Bay Area Air Quality Management District is proposing a minor revision to the Major Facility Review Permit for the Potrero Hills Landfill, Facility Number A2039, and is submitting the permit to EPA for review.

The proposed permit revision is primarily a modification of the landfill gas collection system involving the installation of new gas collectors and extraction wells and the removal of unproductive collectors. The facility has also requested that the Responsible Official and Facility Contact be changed and that the Wood Grinding Operation (S-10, S-11) be removed from the permit. In addition, the District intends to make various other revisions to the permit to update requirements, add clarity, and standardize permit text.

This revision is minor pursuant to BAAQMD Regulation 2-6-215 and will be effective immediately. The permit will be formally re-issued after EPA review. This revision is not subject to public comment and therefore, requires no public notice.
