Dear Ms. Cabral:

As the North Bay Market Area Manager, I am responsible for the operation of several of Waste Management's (WM) Northern California Sites. In this capacity, I am responsible for the operation of over 250 employees and over \$57.6 million dollars in revenue (\$25 Million in 1980 Dollars). Therefore, as the duly "Authorized Representative", I am the "Responsible Official" for the Altamont Landfill and Resource Recovery Facility pursuant to Regulation 2, Rule 6: Major Facility Review, Section 223.1. This section states that "*Corporation: The responsible official shall be a president, secretary, treasurer, or vice president in charge of a principal business function or shall otherwise be a duly authorized representative if:*

- 1.1 *the representative is responsible for the overall operation of the facility, and*
- 1.2 *either the duly authorized representative is responsible for the operation of facilities that employ more than 250 persons or that have gross annual sales or expenditures exceeding \$25 million in 1980 dollars or the APCO has approved a petition from the original responsible official to allow the duly authorized representative to be the responsible official."*


As the Responsible Official per Regulation 2, Rule 6: Major Facility Review, Section 223.1, I hereby designate Ken Lewis, who is the District Manager as the duly "Authorized Representative" and consequently the "Responsible Official" at the Altamont Landfill and Resource Recovery Facility for past, present, and future Major Facility Review purposes. I also request that the Air Pollution

Control Officer approve this petition pursuant to Section 2-6-223.1.2 to designate Ken Lewis as the "Responsible Official" for Altamont Landfill and Resource Recovery Facility.

WM looks forward to your approval of this Petition and the designation of Ken Lewis as the "Responsible Official" Altamont Landfill and Resource Recovery Facility. Ken Lewis will act in this capacity unless we receive written denial of this petition.


