This is to advise you that the Bay Area Air Quality Management District is proposing a minor revision to the Major Facility Review Permit for Waste Management of Alameda County, Facility Number A2066, and is submitting the permit to EPA for review.

The purpose of the minor permit revision is to modify permit conditions related to the landfill gas collection system for the S-2 Altamont Landfill. These condition revisions will update the current landfill gas collection system description, revise the authorized collection system alterations, add the flexibility to temporarily disconnect a few individual gas wells from the vacuum system, and establish an alternative wellhead temperature standard and wellhead CO limit for a few gas wells. This action will not result in any emission increases.
