This is to advise you that the Bay Area Air Quality Management District is issuing a minor revision to the Major Facility Review Permit for Waste Management of Alameda County (Facility Number A2066) pursuant to Application # 16864.

On July 30, 2008, the District proposed a minor permit revision for this facility. The purpose of this minor revision was to modify permit conditions related to the landfill gas collection system for the S-2 Altamont Landfill. These condition revisions updated the current landfill gas collection system description, revised the authorized collection system alterations, added the flexibility to temporarily disconnect a few individual gas wells from the vacuum system, and established an alternative wellhead temperature standard and wellhead CO limit for a few gas wells. This action did not result in any emission increases.

The EPA comment period ended on September 13, 2008. No comments were received from EPA.

The District has decided to issue the revised permit incorporating the proposed minor revisions above. The final revised permit can be viewed on the BAAQMD website at [http://www.baaqmd.gov/pmt/title\\_v/public\\_notices.htm](http://www.baaqmd.gov/pmt/title_v/public_notices.htm).
