This is to advise you that the Bay Area Air Quality Management District is proposing a minor revision to the Major Facility Review Permit for the Tri-Cities Landfill, Site Number A2246 (Application 9790). The purpose of this minor permit revision is to make the following changes to the Title V permit to reflect recent District permitting activity:

- Replace existing Landfill Gas Flare A-2 with new Landfill Gas Flare A-3.
- Remove the Custom Schedule of Compliance previously added to accommodate the use of a temporary landfill gas flare.

The replacement of the flare is a minor revision pursuant to BAAQMD Regulation 2-6-215 and will be effective immediately. The permit will be formally re-issued after EPA review. This revision is not subject to public comment and therefore, requires no public notice. Removal of the Custom Schedule of Compliance will not be effective until formal re-issuance of the permit.
