This is to advise you that the Bay Area Air Quality Management District is issuing a significant revision to the Major Facility Review Permit for the Tri-Cities Landfill. (Facility # A2246) pursuant to Application # 9907.

The District proposed a significant permit revision for this facility on May 15, 2006. The primary purpose of the revision is to add a Permit Shield to subsume the monitoring requirements of Regulation 8, Rule 2 "Miscellaneous Operations" with those of Regulation 8, Rule 40 "Aeration of Contaminated Soil and Removal of Underground Storage Tanks". In conjunction with the subsumed requirements, Permit Condition #8366, Part 17 was replaced with a new Part 17 that does not require a daily demonstration of compliance with Regulation 8, Rule 2 (15 lb/day VOC limit).

In lieu of modifying the permit and subjecting it to another review period, the District has decided to issue the permit as proposed and address the requested changes to permit conditions during the Title V permit renewal process, which is currently underway.
