Dear Ms. Jordan:

This is to advise you that the Bay Area Air Quality Management District is issuing a significant revision to the Major Facility Review Permit for Sonoma County Central Landfill. (Facility # A2254) pursuant to Application # 9277.

The District proposed a significant permit revision for this facility on July 20, 2005. The purpose of this revision is to change the parameter monitoring for the Landfill Gas Fired IC Engines at the facility from exhaust gas temperature to exhaust gas oxygen content as an equivalent means of demonstrating ongoing compliance with NMOC destruction efficiency requirements.

No comments were received from EPA or the public. However, the following minor comments were made by the facility:

- Change the title of the facility contact, Alex Sebastian, from "Plant Site Manager" to Senior Civil Engineer.
- Update the numbers of gas collection wells and collectors given in Table II-A and Permit Condition #4044, Part 4 to account for recent construction activities and include Application #9584 in the list of applications describing system components.
- Add a clause to Permit Condition #19933, Part 11 to give the facility up to 90-days from the permit issuance date to comply with the new IC engine parameter monitoring requirements.

The District supports the comments made by Sonoma County and has made the appropriate minor changes to the permit.
