Dear Ms. Jordan:

This is to advise you that the Bay Area Air Quality Management District is issuing a renewal of the Major Facility Review (Title V) Permit for Sonoma County Central Landfill. (Facility # A2254) pursuant to Application #13090.

The District proposed a Notice Inviting Written Public Comments regarding the renewal MFR permit for this facility on January 8, 2007. No comments were received from EPA or the public. However, Sonoma County made the following comments on the proposed permit:

1. Recent construction activities have changed the total numbers of gas collection system components (wells and collectors) that are represented in the permit. The correct numbers given in Table II-A and Permit Condition #4044 Part 4 should be **20** collectors and **130** wells.
2. Permit Condition #4044 Part 4b (pertaining to equipment for which an Authority to Construct has been issued, but has not been installed) is out of date with recent construction activities.
3. The amount of waste and cover materials allowed at the landfill by Permit Condition #4044 Part 1 (32.65 million cubic yards, which is correct) is not correctly represented in Table VII-A.

The District supports the comments made by Sonoma County and has made corrections in the Final Title V Permit.
