The District has completed its evaluation of the application for renewal of the Major Facility Review Permit for the following facility:

The District has made a preliminary decision to issue the Major Facility Review Permit, but the final decision on the permit issuance will consider public and EPA comments on this permit. The notice inviting written public comments will be published in the San Jose Mercury News. The final date for comments is April 3, 2009.

The initial Title V permit for this facility was issued on June 13, 2003. The permit was revised on October 7, 2003; this proposed permit renewal represents the second revision. Details of the previous revision can be found in Section X of the permit "Revision History". All changes to the most recent version of the permit are clearly shown in ~~strikeout~~/underline format.
