Dear Ms. Jordan:

This is to advise you that the Bay Area Air Quality Management District is issuing a renewal of the Major Facility Review (Title V) Permit for City of Mountain View (Shoreline) (Facility Number A2740) pursuant to Application # 17127.

The District proposed a renewal of the Major Facility Review permit for Facility # A2740 and issued a notice inviting written public comments on April 29, 2009. The public comment period ended on June 11, 2009 and the EPA review period ended on June 14, 2009. No comments on this proposed MFR permit renewal were received from the public, EPA, ARB, or the applicant.

The District has made the following administrative revisions to the permit:

- Corrected the total number of horizontal and vertical wells in each area location of the existing landfill. The designation for these wells was correct in the permit distributed for public comment.
- Corrected the following citation: Part III, Generally Applicable Requirements, EPA Reg. 40 CFR 82, Subpart F, Sections 82.156, 82.161, and 82.166 - Protection of Stratospheric Ozone was deleted. This landfill is closed and waste containing ozone depleting refrigerant can no longer be disposed at this site.
