This is to advise you that the Bay Area Air Quality Management District is proposing a minor revision to the Major Facility Review Permit for the facility listed below and is submitting the permit to EPA for review.

The purpose of this minor revision is to make the following changes to the permit: Two new microturbines at this facility, Sources S-16 and S-17, have replaced two old microturbines, S-12 and S-13. The associated permit conditions for these sources have been revised. Administrative changes have been made to correct and update regulatory amendment dates, add applicable requirements, and correct source references.

This revision is minor pursuant to BAAQMD Regulation 2-6-215 and will be effective immediately. The permit will be formally issued after EPA review. This revision is not subject to public comment; and therefore requires no public notice.
