Dear Ms. Jordan:

This is to advise you that the Bay Area Air Quality Management District is proposing a minor revision to the Major Facility Review Permit for Hubbell Lenoir City, Inc., Facility Number A2918, and is submitting the permit to EPA for review.

The purpose of the minor permit revision is to modify existing Permit Condition #17170 for Source S5 Auto-con Polymer Concrete Mixing Machine. Current permit conditions limit the resin stripping material to one specific product. The applicant is proposing to use a new resin stripper, ACL-23, with less volatility (203F flashpoint) and lower VOC content (65 g/l) than the current SVC-12 (160F and 990 g/l) resin stripper. The revised conditions will allow the company to use the new resin stripper and also the flexibility to use any resin stripper that will not result in an emissions increase. These actions are not expected to result in any emission increases.

The proposed minor revision will be effective immediately. The permit will be formally re-issued after EPA review. This revision is not subject to public comment and therefore, requires no public notice.
