This is to advise you that the Bay Area Air Quality Management District is issuing an administrative amendment to the Major Facility Review Permit for Napa-Vallejo Waste Management Authority (Facility Number A9183).

The purpose of this administrative amendment is to change the Responsible Official and Facility Contact information for this site. Although the Title V Permit for this site expired on November 30, 2008, this permit remains in effect due to an application shield. Napa-Vallejo Waste Management Authority submitted a Title V renewal application on May 30, 2008 (Application # 18234) and a synthetic minor permit application on August 21, 2008 (Application # 18923). The District is currently evaluating the synthetic minor permit request for this site and expects to resolve this matter soon.
