The District has completed its evaluation of the application for renewal of the Major Facility Review Permit for the following facility:

The District has made a preliminary decision to issue the renewal Major Facility Review Permit, but the final decision on the permit issuance will consider public and EPA comments on the proposed permit. The notice inviting written public comments will be published in the Oakland Tribune. The final date for members of the public to submit comments is August 30, 2012.

The initial Title V permit for this facility was issued on March 22, 2000 and renewed on September 22, 2005.
