

NOTICE INVITING WRITTEN PUBLIC COMMENTS

NOTICE is hereby given that the Air Pollution Control Officer of the Bay Area Air Quality Management District invites interested persons to submit written public comments on the proposed significant revision to the Major Facility Review Permit for the following Facility:

The purpose of this revision is to increase the short-term limit for sulfur in natural gas to 1.0 grain/100 scf and to delete the hourly and daily SO₂ limits, while continuing the frequency of monitoring for the annual SO₂ limit and to determine allowances. Also, the commissioning conditions have been deleted since the commissioning period was over in 2001.

There will be no increase in the annual regulated air pollutant emissions as a result of the proposed changes.

The Executive Officer/Air Pollution Control Officer invites written comment on the proposed significant revision. Comments must be received August 19, 2004. The public may also request a public hearing for this significant revision.

Significant revisions of Major Facility Review Permits are also subject to review and approval by US EPA. If US EPA has not objected to a proposed significant revision and District has not addressed a public comment in a satisfactory manner, the public may petition US EPA, Region IX, Operating Permits Section at 75 Hawthorne Street, San Francisco, CA 94105, within 60 days after the end of US EPA's review, to reconsider the issuance of the permit.
