Because amendments to the conditions regarding monitoring for BAAQMD 9, Rule 10, Nitrogen Oxides and Carbon Monoxide from Boilers, Steam Generators, and Process Heaters in Petroleum Refineries, and to the monitoring for flares are still pending, the District has decided to postpone the future effective date to December 1, 2004. The District is making this change to non-federally enforceable permit conditions pursuant to BAAQMD Regulation 2-6-201, Administrative Permit Amendment. The changes will be published when the District sends the proposed reopened permit to EPA for their review.
