Powerplants and Ancillary may not be sited or may not be constructed within these areas.

In addition, Develop new sites in designated areas only that has greater relative Merit based on policies on the Mc Ateer - Petrie Act, The Suisun Marsh Preservation Act of 1977 plan.

In order to protect ecological economic and public health of the region, the purpose of designating areas where the siting of Power plants is prohibited is to reduce the significant environmental impacts that these facilities can have on the air quality.

Fossil-fueled power plants can have impacts on biological resources, air quality, water quality, visual access, land use, surrounding community,

power plants using fossil fuels also have significant impacts on air quality, which BCOC does not directly regulate but which is of concern due to the biological, water quality, and community impacts that result from impacts to air quality.

The areas that are not designated are the more urbanized and industrial portions of the shoreline. However, siting impacts can still be significant in undesignated areas due to the proximity of residential neighborhoods (Cordelia Road) or potential public access or land use conflicts. In order to avoid these impacts, power plants should be sited in industrialized locations away from residential areas and include the appropriate pollution prevention technologies and mitigation to reduce local air quality and design features to reduce visual impacts.

The Mc Ateer-Petris act requires to protect environment... "such as air quality. One of the most significant impacts that results from the generation of electricity is to air quality. The air quality impacts of power plants are substantial and include emissions

of pollutants that contribute to global warming, ozone, smog, acid rain and the eutrophication of water bodies.

The generation of electricity contributes to 28 percent nitrogen oxide, 67 percent of sulfur dioxide, 36 percent of carbon dioxide and 33 percent of nitrogen oxide, 33 percent of mercury that is emitted nationwide. The health effects carbon monoxide (CO) include the disruption of the delivery of oxygen to the body's organs and tissues which can affect people with coronary artery disease, congestive heart failure, obstructive lung disease, the elderly, new born infants and fetuses. The effects of particulate matter (PM) usually depend on the toxicity of its constituent pollutants, but the general effects include premature death, aggravation of respiratory and cardiovascular disease.

Over the past 25 years the emission rates of critical air pollutants from California's generating plants have significantly decreased, due to the Clean Air Act, Thank you!

However, power plants, Peaking Power plants, still adversely affect air quality, particularly in the areas surrounding power plant facilities.

areas that contain concentrations of generating facilities or older plants that lack emission control technologies receive the greatest air quality impacts. Natural and cultural resources, siting these facilities away from residential uses recreational resources and sensitive habitat areas. (Suisun Marsh). will reduce the impacts that impaired air quality can have on these resources.

66646. Construction of New or Expanded Thermal Electric Generating Plants Within Suisun Marsh; Condition.

Notwithstanding any other provision of this title, except subdivisions (b) and (c) of Section 66645, and notwithstanding any provision of Division 19 (commencing with Section 29000) of the Public Resources Code, new or expanded thermal electric generating plants may be constructed within the Suisun Marsh, as defined in Section 29101 of the Public Resources Code, or the area of jurisdiction of the commission, if the proposed site has been determined, pursuant to the provisions of Section 25516.1 of the Public Resources Code, by the State Energy Resources Conservation and Development Commission to have greater relative merit than available alternative sites and related facilities for an applicant's service area which have been determined to be acceptable pursuant to the provisions of Section 25516 of the Public Resources Code.

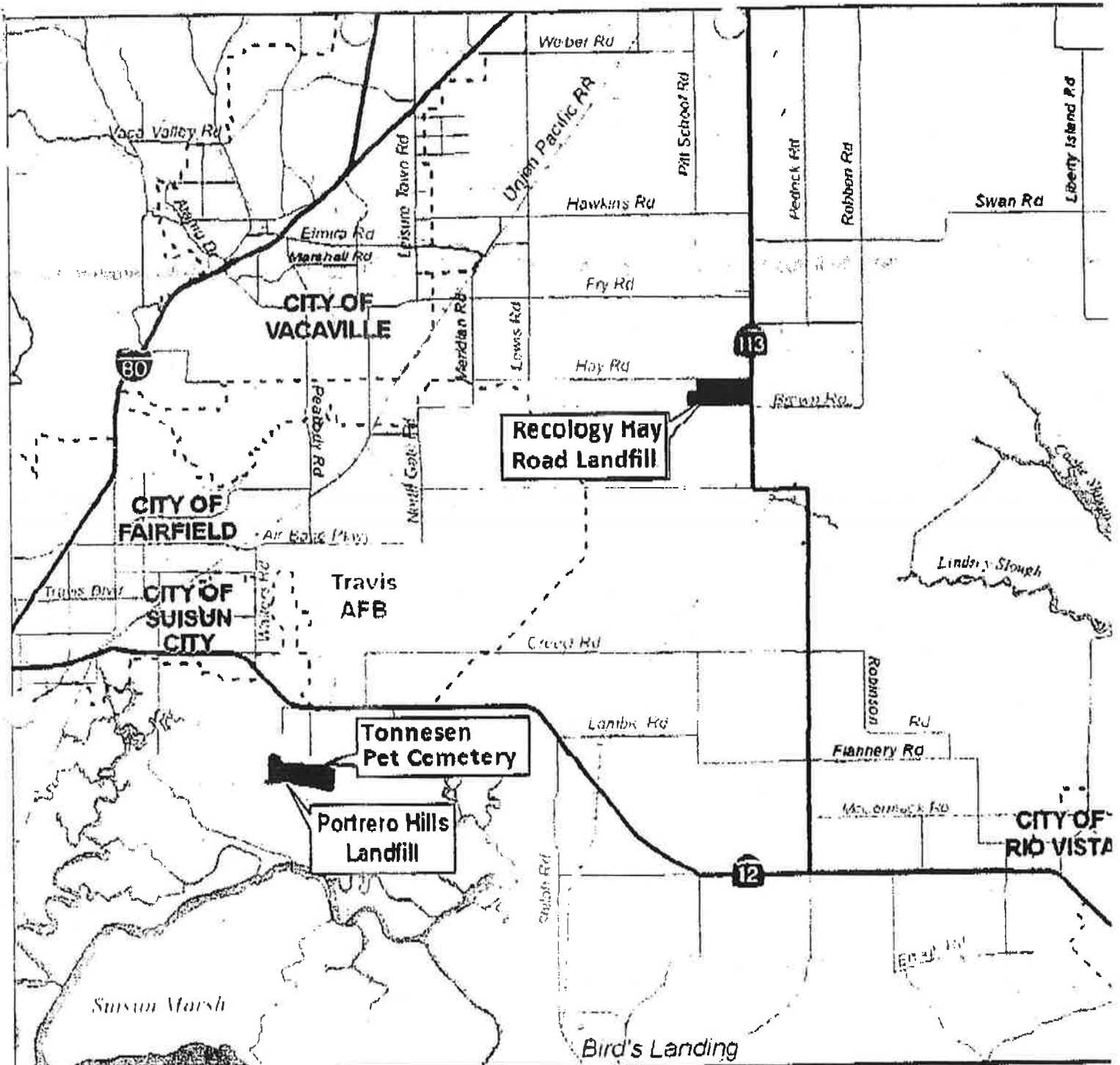
If a site and related facility found to be acceptable by the commission pursuant to Section 25516 is located in the coastal zone, the Suisun Marsh, or the jurisdiction of the San Francisco Bay Conservation and Development Commission, no application for certification may be filed pursuant to Section 25519 unless the commission has determined, pursuant to Section 25514, that such site and related facility have greater relative merit than available alternative sites and related facilities for an applicant's service area which have been determined to be acceptable by the commission pursuant to Section 25516.
