

## NOTICE INVITING WRITTEN PUBLIC COMMENTS

**NOTICE** is hereby given that the Executive Officer/Air Pollution Control Officer of the Bay Area Air Quality Management District invites interested persons to submit written public comments on the proposed initial Major Facility Review Permit for the following facility:

Major facilities are required to obtain operating permits under Title V of the 1990 Clean Air Act Amendments, the Federal Operating Permit Program and the District's Regulation 2, Rule 6 - Major Facility Review. The permits summarize all air-related requirements that apply to each source of emissions at each facility. Major Facilities have the potential to emit pollutants at rates in excess of the Major source thresholds. The current actual emissions from the NRG Energy Center San Francisco facility are as follows:

Nitrogen Oxides	19.5 tons/year
Carbon Monoxide	19.6 tons/year
Precursor Organic Compounds	1.7 tons/year
Particulate Matter	1.7 tons/year
Sulfur Dioxide	0.3 tons/year
Greenhouse Gases	84,575 tons per year

The Air Pollution Control Officer invites written comment on the proposed initial Title V permit for the facility listed above. Comments must be received by January 12, 2012. Any interested person may also request a public hearing for this permit.

Major Facility Review Permits are also subject to review and approval by US EPA. If US EPA has not objected to a proposed permit and District has not addressed a public comment in a satisfactory manner, the public may petition US EPA, Region IX, Operating Permits Section at 75 Hawthorne Street, San Francisco, CA 94105, within 60 days after the end of US EPA's review, to reconsider the decision to not object to the permit.
