



PRE-TAX COMMUTER BENEFITS

IMPLEMENTING A PRE-TAX BENEFITS PROGRAM

- ① Check with the company tax specialist for tax deductions or claims specific to your situation.
- ② Determine which employees will receive benefits. All full-time and covered (20 hours/week) must be eligible to receive the benefit according to the Bay Area Commuter Benefits Program, but employers may choose to offer the benefit to other part-time or seasonal workers as well.
- ③ Decide to administer the benefit internally or via outsourcing. There are advantages to both. Typically, smaller companies will manage their own programs (see the next page for additional information on vendors).
- ④ Decide how to distribute the benefit to employees (if using a vendor, the vendor typically takes on this task).
- ⑤ Update the personnel manual to include the benefit and qualifications for receiving the benefit.
- ⑥ Announce and market the benefit, and educate employees about it. In any worksite or employee documentation, list all the rules, deadlines and limitations. Provide a convenient sign-up sheet, as employees will need to authorize any pre-tax deductions.
- ⑦ Make changes as necessary to W-2 forms/information. Vendors can assist with this as well.
- ⑧ Purchase/distribute the benefit. If using a vendor, this task will be completed for you. It may also be interesting to monitor the program and analyze savings, and vendors can assist in these areas as well.
