# COMMUNITY OPEN HOUSES

The Bay Area Air Quality Management District invites you to participate in an Open House to learn about revisions to Regulation 2, Rule 5. At the Open Houses, participants can view displays, speak with Air District staff, ask questions, and offer comments on draft measures for the New Source Review of Toxic Air Contaminants.

### Revisions to Regulation 2, Rule 5: New Source Review of Toxic Air Contaminants

This rule implements the Air District's new source review (NSR) program for stationary sources of toxic air contaminant (TAC) emissions. The rule requires health risk assessments (HRAs) for new and modified sources, if the toxic air contaminant emissions from a proposed project will exceed the Air District's health risk assessment trigger levels. This rule mitigates potential increases in public health risks by requiring best available control technology for toxics (TBACT) and by limiting project health risks. The rule also delineates procedures for calculating toxic air contaminant emissions and for evaluating health impacts that may result from proposed projects.

#### This rule revision will:

- Implement the State's revised Health Risk Assessment and Risk Management Guidelines for Stationary Sources.
- Incorporate new and revised toxic air contaminant emission rate trigger levels for health risk assessment requirements and relocate the Air District's toxic air contaminant trigger level table.
- Simplify TAC emission calculation procedures for modified sources and update regulatory language for consistency with State guidelines.

Overall, these proposed rule revisions will increase the stringency of the Air District's Toxic NSR Program.
